It saddens me very time I hear this type of statement, because CERF (or eye) testing is as important to our PWDs as it should be to us. And indeed they can suffer from many of the same ophthalmologic conditions as we do.

Yes...we have the ability to do genetic testing for PRA (progressive retinal atrophy), causing early blindness in our dogs, but a myriad of other problems can be discovered upon eye exams. These conditions can range from inherited disorders, such as juvenile cataracts to mid-life glaucoma to old age cataracts. The eyes can also reflect symptoms of systemic disease, such as diabetes, liver disease, etc.

Even if you choose to pursue this exam on a sporadic basis (annual exams are required for breeding dogs), it would be beneficial for you to submit your dog's eye exam results, when conducted by a board-certified veterinary ophthalmologist, to CERF (Canine Eye Registry Foundation) for a nominal fee, which contributes to our data base for PWD health issues.

So, just because you "don't plan to breed", it is still important to maintain you dog's health and we all know that prevention and early detection of health problems is of utmost importance in meeting that goal.

It is important to the success of our Club that you join or continue to participate this year. We have a number of activities planned. Our events calendar will be sent out shortly and we are hoping you have enjoyed your issues of our newsletter.

Before you open your application, please note specifics related to memberships statuses and time lines.

With the first set related to **types of memberships** we hope to address the fact that with the number of Regular members we have, it is difficult to obtain quorums for voting at our meetings.

REGULAR voting membership remains **\$30.00**

REGULAR HOUSEHOLD 2nd voting membership is now **\$15.00**

ASSOCIATE non-voting membership, now open to those out of geographic area or a second household (not active) member (still eligible for Club awards) is **\$10.00**

JUNIOR under 18, non-voting membership is **\$10.00**

There have also several **membership regulations**:

All dues are **due by January 1**. If dues are not paid by that date, you will not be eligible to vote or for Club benefits until your membership is received.

In order to be eligible for Club awards - ex water trial trophies, annual awards, etc., dues must be received by **April 1**. Memberships received after that date must include a **\$5.00/membership late fee**.

As of **August 1**, dues will be considered **lapsed** and all members must re-apply/apply (two sponsors, one of who is a Regular member, is required) in January 2012.

As per our Bylaws, new (or lapsed) members are required to list **two** Club members as **references** (one of who must be a Regular member), who will be contacted by Membership prior to Club acceptance.

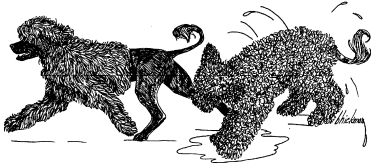
I know this is a great deal of information to digest, but unfortunately as we have grown it was time to "firm up" our membership procedures.....
