Lumberton Water Workshop

Movers and Shakers Water Practice at the Flebotte Pond

FRIDAY APRIL 4TH AND SATURDAY APRIL 5TH

Note this is a Friday and Saturday-----not Saturday and Sunday. This is a land workshop which will cover exercises and any exercise changes from last year. We will be working on land exercises to prepare the teams for water exercises. Obedience skills will be put to the test for the land workshops. This is a hands on workshop so the first part of the day will cover the exercises while the second part of the day will be hands-on exercises with your dog.

SATURDAY JUNE 7TH AND SUNDAY JUNE 8TH

This is a hands on workshop to prepare the teams for the July Water Trial by practicing the exercises at each level. The workshop will be on the boats in the water and using all the equipment necessary at the level you are working with your dog. Some run-throughs may be done.

SATURDAY JUNE 21ST AND SUNDAY JUNE 22ND

Like the earlier weekend, this is a hands on workshop to prepare the teams for the July Water Trial. The emphasis will be on specific problems you may have with your dog in and around the water with the exercises. Some run-throughs may be done.

Remember that all Movers and Shakers practices are \$10.00 per dog per day. This is to offset some of the cost of the Water Trial in July.

Please think about the opportunity for practice. There will be many experienced Water Trial teams to help with most any training issues you have.



Pesci: Wild Thing to Performance Dog

Pesci is a 5 year old spayed female PWD (Cove's End Pescadora OA OAJ OF WWD). As most of the Movers and Shakers members know, in her younger days, she had a reputation for being a wild, hard to control dog who loved "zoomies" more than anything.

We brought her home from the breeder with high hopes of turning her into an agility and water performance dog. She quickly learned to run through tunnels, run over the mini-teeter and bang the wobble board and she loved the water. We were, however, blissfully ignorant of the amount of work that was required to bring out her potential.

When we retired and moved to North Carolina, Pesci was a year old. We immediately started taking obedience and then agility introduction classes at Bon-Clyde Learning Center in Sanford. We also connected with the Movers and Shakers and were introduced to water work at Jill Flebotte's pond in Creedmoor, NC.

Those early classes opened our eyes to how little we really knew about training a performance dog. We longed to be able to do the things that we saw other dogs doing. In hindsight, we tried to rush the process of giving her the solid foundation in obedience that would be necessary for us to succeed. Every time she had to work off-leash, she got the "zoomies". Eventually she understood the exercises in water and she quickly became adept at taking the agility obstacles. Our first performance attempt was during the 2010 Southern Splash. Pesci swam out to retrieve the dummy in the first Junior exercise and brought it nicely to shallow water but then dropped it to run over to investigate the boats! Her first two agility trials in the spring of 2011 had similar results: running wild on the course or failing to pay any attention to her handler.

Pesci got her first "Q" in agility (Novice JWW) in June 2011 but more were slow in coming. While the "zoomies" were fewer we had no start-line-stay. We started to make her sit and wait for her meals after the dish was put down. This routine helped in practice but trials were another thing altogether. I also started making her wait during water practices while I placed her float line in the water and she became quite good at it. This newly-found patience paid off at Southern Splash 2011 where she finally passed her Junior exercises.

During a "focus" class offered at Bon-Clyde that fall we started to see what we had "glossed over" in her earlier training. We also took her back for a "refresher" course in obedience. The additional training (as much for the handlers as for the dog!) started paying dividends at Southern Splash 2012 where she got her Apprentice title and almost got her WWD. In August, she got her first agility title (NF) and a leg for her NA title. In September, she aced her WWD in Maryland and in the fall, completed her NAJ title in agility. I'm sure one of the reasons for this newfound success was the fact that she was now three and a half and had definitely matured. Success continued in 2013 as she finished her NA, OA, OAJ and OF titles and now has 2 legs each toward her AX and AXJ titles. As a bonus, Pesci will soon enter her first obedience competition. We are very happy that she is no longer known as the dog with the zoomies.

With my one year old puppy, Dante, I will definitely concentrate on obedience and focus first! Learning the obstacles and the water trial exercises was the easy part with Pesci. However, without the focus and the foundation in obedience it will not translate to success on the agility course or in the water.
